## RAB members meet to discuss cleanup progress at Edwards AFB

t the November 2023 Restoration Advisory Board meeting in Boron, California, Edwards Air Force Base remedial project manager Paul Schiff briefed the board members about ongoing base cleanup efforts and environmental restoration activities over the past six months. The board consists of base officials, state and federal regulators and public representatives who foster two-way communication between the public and those responsible for environmental cleanup.

Starting with an update on the Community Involvement Plan, which identifies community issues and concerns related to the Edwards ERP, Schiff said that the August 2023 CIP is available on the Edwards public website (www.edwards.af.mil/about/environment) with a link on the RAB Facebook site (www.facebook.com/RAB.Edwards).

Schiff also discussed the Phase I Remedial Investigation efforts underway for aqueous film-forming foam areas involving perfluoroalkyl and polyfluoroalkyl substances, or PFAS for short. On Nov. 12, 2021, field event No. 1 was completed with groundwater sampling performed at 162 existing monitoring wells. From October 2022 to November 2022 field event No. 2 was conducted, which included: monitoring well installation, source area sampling and groundwater sampling at 340 monitoring wells. Starting January 2024, field event No. 3 will include the installation of 36 monitoring wells, 85 soil borings and sampling of 430 groundwater monitoring wells.

For Operable Unit 1/8 Main Base, Schiff said Technical Working Group meetings continue to be held to resolve issues such as vapor intrusion for incorporation into the Feasibility Study Addendum. A groundwater and soil investigation was conducted in support of the OU1/8 FS Addendum to finish characterizing Site 58 soil and groundwater in addition to OU1/8 nitrate and trichloroethene groundwater contaminant plumes. He said that the investigation will help determine whether biodegradation of TCE is occurring. Additionally for OU1/8, the semiannual indoor air sampling results from May 18, 2023 for Building 1807 confirmed that TCE levels are below all action levels with the heating, ventilation and air conditioning operating continuously. The Draft Building 1807 Indoor Air Monitoring Report for November 2022 through May 2023

was submitted in August 2023 for regulatory review. Schiff noted that the next sampling event was scheduled for Nov. 28, 2023.

Schiff reported that execution of the Air Force Research Laboratory Arroyos Record of Decision dispute resolution is ongoing. The Air Force, regulatory staff and legal counsels continue to meet to address the few remaining items of disagreement. Once a Draft Final ROD is agreed to by all parties, the Air Force will prepare and publish a new AFRL Arroyos Proposed Plan, announce availability of the plan for public comment and conduct a public meeting. The public comments will be incorporated into the Final AFRL Arroyos ROD.

Schiff also updated the board members on Site 25. He said the Air Force anticipates submitting a Revised Draft Site 25 FS in the summer of 2024. Simultaneously, the Air Force is developing an updated three-dimensional groundwater model for remedy development using the latest model platform to address regulatory comments. Schiff shared that in August 2023, the Air Force terminated the Site 25 phytoremediation treatability study that used poplar trees to break down contaminants from extracted groundwater. The study was deemed unsuccessful because of the low survival rate of the trees due to high salt content in the soil, high temperature, low humidity and high winds. The study site will be restored to its initial state.

Before ending the RAB meeting, Gary Hatch, 412th Test Wing Public Affairs, informed the board of six public representative vacancies. Two vacancies are for the off-base communities of Boron and North Edwards, while four are for the on-base communities of Main Base, NASA Armstrong, South Base and North Base.

The next semiannual RAB meeting is scheduled to be held in Mojave, California on May 16, 2024. Meeting

details will be advertised in local newspapers and posted on the RAB's Facebook page at www.facebook.com/ RAB.Edwards. The public is encouraged to attend.
